Terms & Conditions



## Shoppers Stop GV offer

**FIRST Power+ Credit Card:** ₹250 worth Shoppers Stop Gift Vouchers on UPI transaction of ₹100 or above done within 15 days of Card set-up

Offer Period: Only for Cards created between 1st Oct'25 to 30th Nov'25

#### Offer Eligibility criteria:

- Valid only on FIRST Power+ primary Credit Cards
- UPI transaction of ₹100 or above to be done within 15 days of the card set-up.
- ₹499 + GST Joining Fee on FIRST Power+ Credit Card is paid
- Offer is applicable only for cards created between 1st Oct'25 to 30th Nov'25
- Applicable once per primary cardholder

#### Steps to Claim Offer:

- 1. Activate your FIRST Power+ Credit Card by paying the Joining fee of ₹499 + GST
- 2. Do a UPI transaction of ₹100 or above within 15 days from card set-up
- 3. On meeting the above two eligibility criteria, the Shoppers Stop Gift Voucher will be issued within 45 days of card set-up subject to fulfilment of the offer terms

#### For instance:

Card set-up date: 2<sup>nd</sup> October 2025

Joining fee payment date: 2<sup>nd</sup> October 2025

UPI transaction date (of ₹100 or above): 10<sup>th</sup> October 2025 Shoppers Stop Gift Voucher credit date: 16<sup>th</sup> November 2025

- **4.** Once the eligible transaction is done, the Shoppers stop voucher will be available in IDFC FIRST Bank Mobile App Rewards Section
- 5. The cardholder will also receive an email confirming the issuance of Shoppers Stop Gift Voucher in the IDFC FIRST Bank Mobile App Rewards Section



- 1 Login to the IDFC FIRST Mobile Banking App
- 2 Navigate to reward redemption platform:
- a. Go to Credit Card >> Rewards Section >> Redeem Now

or

b. Go to Hamburger Icon (≡) in the IDFC FIRST Mobile Banking App >> Credit Card - Rewards




7. Once you login to the Credit Card Rewards Portal, click on the Shoppers Stop banner visible to you.





- 8. Click on Redeem Now
- **9.** Voucher code and PIN shall be displayed. Use the voucher code for redemption online or offline.



- **10.** To check the Shoppers Stop Voucher Code and PIN, cardholder can follow the below steps
  - a Go to the FIRST Rewards Portal
  - **b** Click on Reward Points
  - c Go to "My offers & Benefits"
  - d The availed Shoppers Stop Voucher shall be visible

The Voucher code and PIN shall also be mailed to the cardholder on their registered email address.

- 11. The Shoppers Stop Voucher can be redeemed both online and offline.
  - a. Online:
    - Visit www.shoppersstop.com
    - Select the product of your choice
    - Add product to the cart
    - Checkout > Payment Page
    - Select payment option as Gift Card / E-Gift Voucher
    - Type of Card as "E-Gift Voucher"
    - Enter the voucher code and PIN



- Click on the Redeem Amount
- **b.** Offline (at Stores): The Customer has to show/present 16-digit E-Voucher number along with its 6-digit PIN to the Cashier @ the Billing Counter.

### Important Terms and Conditions:

- 1. E-Gift Voucher is not valid on 22k and 24k gold jewellery and gold coins of any jewellery brand.
- 2. E-Gift Voucher cannot be exchanged for cash as well as smaller e-Gift Voucher denominations.
- 3. Only a credit note shall be issued for part utilization of the e-Gift Voucher.
- 4. Only valid e-Gift Voucher at the sole discretion of shoppers stop shall be accepted for redemption.
- 5. If e-Gift Voucher is lost, misplaced or stolen no duplicate e-Gift Voucher shall be issued.
- 6. Multiple e-Gift Voucher can be clubbed for 1 billing at the store and Online (www.shoppersstop.com)
- 7. E-Gift Voucher can be redeemed during End of Season Sale.
- 8. Balance amount will be available in the e-Gift Voucher on part redemption online and same needs to be used before Expiry date.
- 9. Valid at all outlets of Shoppers Stop, Shoppers Stop Airport Stores, Home Stop, MAC, Bobbi brown, Clinique.
- 10. The transaction initiated through aggregators or payment wallets will not be eligible for the offer if the transaction does not have the specified merchant category.
- 11. The offer is non-transferable, non-cashable and non-negotiable.
- 12. Conditions apply in case of promotions & events subject to Mumbai jurisdiction.
- 13. The Joining Offer shall be available to the Primary Card Members only.
